#### Parent managed head lice program

While it is known that head lice do not carry any infectious disease, the principal, teaching staff and school council at Billanook Primary School have developed a parent-managed head lice program to help parents manage head lice. A group of volunteer parents at the school have coordinated the program and is fully supported by the school. All volunteer parents sign a confidentiality agreement to ensure information privacy for all children and their families.

Program goals include:

- Reduce the frustration and misinformation associated with head lice.
- Decrease the concerns regarding head lice within the school community
- Protect families from misusing potentially harmful insecticide treatments.
- Promote regular home based screening using a conditioner and comb method.

Volunteers use the 'Dry' checking without conditioner method to check your child's hair  
There are no toxic chemicals used and no treatment is undertaken at the school.

#### Please Read This Notice Before Completing The Enrolment Form.

This confidential enrolment form asks for personal information about your child as well as family members and others that provide care for your child. The main purpose for collecting this information is so that Billanook Primary School can register your child and allocate staff and resources to provide for their educational and support needs. All staff at Billanook Primary School and the Department of Education & Training are required by law to protect the information provided by this enrolment form.

This includes information about any medical condition or disability your child may have, medication your child may rely on while at school, any known allergies and contact details of your child's doctor. Billanook Primary School depends on you to provide all relevant health information because withholding some health information may put your child's health at risk.

Billanook Primary School requires information about all parents, guardians or carers so that we can take account of family arrangements. Family Court Orders setting out any access restrictions and parenting plans should be made available to Billanook Primary School. Please tell us as soon as possible about any changes to these arrangements. Please do not hesitate to contact the Principal or Assistant Principal, if you would like to discuss, in strict confidence, any matters relating to family arrangements.

#### **Emergency Contacts**

These are people that Billanook Primary School may need to contact in an emergency. Please ensure that the people named are aware that they have been nominated as emergency contacts and agree to their details being provided to Billanook Primary School.

#### **Student Background Information**
