

Billanook Primary School HOMEWORK POLICY



PURPOSE

To outline to our school community the Department's and Billanook Primary School's policy requirements relating to homework.

SCOPE

This policy applies to students in all year levels and staff responsible for setting and monitoring homework at Billanook Primary School.

RATIONALE

Billanook Primary School recognizes the importance of informing and involving parents with their child's education. Homework that has been organized by teachers is seen as a way of keeping parents informed of the learning happening within the classroom.

Separate to the expectation of homework, we believe that reading regularly to and with a child for the love of it provides a connection between parent and child that helps build strong family ties. Sharing the love of reading as a source of enjoyment builds opportunities for discussion, developing empathy and attachment.

While Billanook Primary School recommends that home learning tasks are completed, we also recognize that family time is equally as valuable and that families have varying priorities and commitments that sometimes conflict with homework completion. Completed homework tasks will be sighted and celebrated, but not assessed.

Billanook Primary School also agrees that it is good practice for teachers to regularly review the management of home learning in the curriculum.

Billanook Primary has developed this Homework Policy in consultation with the School Council to support student learning and wellbeing by:

- providing opportunities for students to review, revise and reinforce skills
- encouraging students to enrich or extend knowledge
- fostering good lifelong learning and study habits
- supporting learning partnerships with parents/carers.

DEFINITIONS

Homework is tasks assigned to students by teachers that are intended to be carried out during non-school hours.

POLICY

At Billanook Primary School all homework set and monitored by teachers will be:

appropriate to students' skill level and age

- curriculum-aligned
- designed to help students develop as independent learners
- an opportunity for parents/carers to partner in their child's learning (where appropriate)

Billanook Primary School understands that students have different learning strengths, preferences and interests and may approach learning activities and homework differently. If parents/carers are concerned their child may not understand the homework tasks that have been set or is spending a long period of time completing their homework, we encourage parents/carers to speak to their child's teacher.

Prep to Year 4

From Foundation to Year 4, homework will mainly consist of daily reading to, with, and by parents/caregivers or older siblings.

Extra learning tasks may be set by the teacher, including possible math or literacy practice. This should generally not exceed 30 minutes per day (dependent on the specific needs of students). Homework completion is recommended but not enforced.

Year 5 - 6

In Level 5 and 6, homework will include daily independent reading (student choice or teacher directed) and may include extension of class work, projects, assignments and research. This will generally be around 3 hours per week and will assist in building towards the expectations of secondary school. At this level there is an expectation that the homework set is completed.

SHARED EXPECTATIONS AND RESPONSIBILITIES

Homework is a shared responsibility between the school, teachers, students and their parents/carers. In order to get the most out of homework tasks, it is important that everyone understands their obligations and responsibilities.

Responsibilities and expectations for leaders at Billanook Primary School are to:

• advise teachers, students and parents/carers of homework expectations at the beginning of the school year and provide them with access to the homework policy.

Responsibilities and expectations for teachers at Billanook Primary School are to:

- set homework that is curriculum-aligned and appropriate to the student's skill level and age
- ensure homework tasks planned to support student learning
- ensure the amount of homework set aligns with our school policy

Responsibilities and expectations for **students** are:

- being aware of the school's homework policy
- discussing homework expectations with their parents/carers
- accepting responsibility for the completion of homework tasks within set time frames
- seeking assistance when difficulties arise
- where appropriate, organising their time to manage home obligations, participation in physical activity and sports, recreational and cultural activities

Responsibilities and expectations for parents/carers are:

 ensuring there is a balance between the time spent on homework and recreational, family and cultural activities

- talking to teachers about any concerns they have about the homework
- discussing homework with their child in their first language, if English is not the main language spoken at home,
- encouraging independence in the completion and return of homework
- ensuring there is a quiet study area for their child to complete homework.

COMMUNICATION

This policy will be communicated to our school community in the following ways:

- Included in staff induction processes and staff training
- Available publicly on our school's website
- Linked in staff handbook/manual
- Reminders in our school newsletter
- Discussed at parent information nights/sessions as appropriate
- Discussed at student forums as appropriate
- Hard copy available from school administration upon request
